We'll pick up right where we left off, - talking about the tools used by the Global Elites to achieve their ultimate end: A One World Government.

MORE WAYS & MEANS

In the last installment we summarized briefly the Global Elites' use of cutting edge emerging technology, the education system and environmental concerns in their drive to produce world government. Today, we'll look at a very problematic area: Islamic terror.

Using The Terror

As we've seen from their own words with regard to the environmental and population issues: The '*Powers-That-Be*' need not create the problem in order to use it to their advantage. Manipulated or not, the phenomenon of Radical Islamic terror is a tool that can be well used to advance their cause. First, let's be clear. No one in the New World Order invented modern terrorism. Violence was inherent both in the life and career of Mohammed and the history of its spread; - as well as in the struggle between Sunni and Shiite; - the two main branches of Islam. This goes all the way back to the founding of the religion of peace. It is the Islamic holy books; - Koran and Hadith; - that both command the use of forced conversion and justify the use of violence, - even against civilians, - so long as it advances the cause of Islam. That is the only requirement. [Imams even used that line of reasoning to excuse the slaughter of children in the Beslan massacre in Russia.] Want precedent? Mohammed himself led over 100 military expeditions and ordered the mass executions of his enemies. The violence of Islam held its own in a violent age, with the dream of a worldwide Islamic empire, (caliphate) ultimately succumbing only after Turkey's Ottoman Empire fell after WWI. In the words of one writer: The "western advancement in warfare eventually overwhelmed the archaic ways of Islam". The terror took its modern form in Egypt in 1928 with the foundation of the Muslim Brotherhood.¹

The terrorist momentum really took off in the 1960's, when "secular movements such as Al Fatah and the Popular Front for the Liberation of Palestine" began to murder civilians even outside the contested area with Israel. [This is a good time to remind you that there was not a Palestinian movement, or Palestinian people, when the area they are now claiming was held by Egypt and Jordan! In fact, there never has been a Palestinian State.] Thus was born the era of kidnappings and hijackings and car bombs that reached its peak in the murderous rampage of the 11 Israeli athletes at the Munich Olympics in 1972. Then by the early 90's, Osama bin Laden's al-Qaeda internationalized terrorism, superimposing a transnational network to coordinate jihad around the globe; - all in search of the reestablishment of the world-wide Muslim Caliphate.² The true colors of Islam were showing through the actions and plans of the Islamic fundamentalists that engineered attacks against the US in Lebanon (Hezbollah) to the Twin Towers (al-Qaeda). Only means, - not values had changed in 1,400 years.³

Jump forward to the aftermath of 9/11, and we see how terrorism has been put to use by the NWO types to achieve their own purposes, - all under the plausible, - (and in many ways reasonable), goal - of maintaining the free-flow of necessary oil. We start by recognizing that Islamic terror is real, - maniacally opposed to both the legitimate and illegitimate aims of America, Israel and Western business interests. It is necessary that it be opposed and eradicated and defended against. So the US, - with the help of the Israeli's and the UK, - along with some other allies, - is at war with the terrorists and the states that sponsor them. Now among the US allies in that war are

Pakistan and Saudi Arab. One problem with that arrangement: Both have less than stellar records operating against terrorists. In Pakistan, for instance, - the Musharraf government has been unable or unwilling to wrest control of the border areas which are run instead by the Paki Taliban and are likely the hideout of bin-Laden himself. The Saudis pose even more of a problem. With the winking approval of the Saudi Royals or not, - the Kingdom is a major feeder of funds and insurgents to Iraq in support of the terror.

It starts right with 9/11 itself. Senior American officials have implicated Saudi government operatives in the very planning of the attacks. According to reports, that is what is contained in the classified missing 28 pages of the Congressional Report on the 9/11 incident. There is said to be a “coordinated network” connecting even the pilot of one of the hijacked planes with both the government and “the very top levels of the Saudi royal family”.⁴ One report even implicated the nephew of King Fahd.⁵ Need more? In 2003, the UK Guardian connected a Saudi envoy in London to the 9/11 attacks.⁶ In addition, it is no secret that millions of dollars for al-Qaeda have been raised from well-to-do Saudi citizens and funneled to that terror organization through the Saudi banking establishment and charity fronts. In fact, that’s al-Qaeda’s primary source of cash; - wealthy Saudis.⁷ As for terrorists themselves: Using several different measures, it looks like around half of the foreign fighters in Iraq are Saudi nationals responsible for about 61% of the suicide bombings there during one period in 2006. (Now admittedly some of these are from Arab tribes operating on both sides of the Iraq-Saudi border and professing allegiance to neither.) All the while the Imams of the Kingdom continue to exhort this violent jihad against the West, - against Americans and Jews, - in the mosques with impunity.^{8 9}

So why has the US government ignored or swept this connection between the Saudis and terror, - under the rug? The answer is nothing less than oil. One fourth of the globe’s petroleum buys you a lot of clout, - a lot of immunity. It is the cooperation of the Saudi Royals that is keeping a weakening US dollar tied to the petro-dollar system, thereby propping up the American currency. And though they may be imperfect allies in the terror, - they are *sometime* allies just the same, - helping to facilitate an American presence in the region. So Washington puts up with a little more, - and hushes terror-ties that would be embarrassing – and is willing to sacrifice the interests of their long-time ally Israel; - all for the continued access to Arab oil supplies. In fact there’s so much winking going on, they may as well be blind.¹⁰

So that’s perhaps the government’s rationale for accepting a lot of guff from the Saudis. But there’s something, bigger and more sinister behind that. Just look at the interests of NWO aficionados that run the world. What’s one of their biggest interests? Why its oil! Imagine that! That’s what the Rockefeller’s started in (Exxon). That’s also the commodity, - along with money itself, - that so many of the Bildebergers, - the REAL power brokers, - deal in. Yes, there are the Rockefeller’s and the Morgans and the Queen of the Netherlands (Dutch Shell) and the Rothschilds; - and the oil is tied to the money. And the oil is the money! Again this is above national governments. Presidents and Prime Ministers are just players in the game, - pawns to be used to further the ultimate ends. The Saudis have oil: Therefore they are players too!¹¹

And what’s the game the Saudi Royals are playing? Survival! They’re operating, perhaps on borrowed time, with the Radical Islamists perfectly willing to destroy the Kingdom in pursuit of their Caliphate. So they both resist domestic terror and allow the near-free-flow of terror activity against the West to emanate from their own soil. And here’s the price that Washington pays for their acquiescence to these terror activities: In the summer of 2007, ABC News reported that 300 al-Qaeda members were dispatched to the American Homeland to carry out massive terror strikes here.¹² According to the FBI, Hezbollah terror teams have also infiltrated the US, with “an extensive network of operatives on American soil” numbering in the hundreds and capable of using chemical and possibly nuclear or dirty bombs.¹³ And in 2004 “DEBKA-Net-Weekly broke the story that Iranian and Iran-sponsored

surveillance teams had been discovered hanging about outside Israel's diplomatic missions in the United States, South America, West Europe and the Middle East"¹⁴ Iran is another major sponsor of terror with ties to both al-Qaeda and more directly to Hezbollah; - the other fully international terror organization.

So from the Illuminati point of view, what would be the purpose of terror attacks on America? To drive the country to a place where the population of the US and the West would accept the prescription of a New World Order. It's been no secret that they seek the organization of the globe into regional spheres of influence. Examples: The European Union, the soon-to-be forming North American Union growing out of the NAFTA trade agreement. Now there is even growing momentum for something called the Mediterranean Union. Under the leadership of French President Sarkozy it is steadily gaining support with Germany and Israel recently signaling their approval. The Mediterranean Union would include not only the European countries on that sea but also the Arab States and even Israel.^{15 16} What's interesting about this is that the geographic extent of such a transnational body would be roughly the same as the old Roman Empire. The prophet Daniel tells us that we will see a revival, in some form, of that Roman Empire as the seat of the Antichrist. The 'terror', - then, could be seen as the vehicle that moves the world's population to the point where they could trade away their nationalist loyalties for a promise of peace and security, when they are under the gravest of perceived threats. That is exactly the plan revealed by the Illuminati and the Occultists and the New World Order types and the Theosophists and sundry others. We've reviewed the quotes of Kissinger and Brzezinski and others among the Bildebergers and their cronies. It is crisis they look for to open the way for the establishment of the One World Government. 1Thessalonians 5:3 warns of the result. **“For when they shall say, Peace and safety; then sudden destruction cometh upon them, as travail upon a woman with child; and they shall not escape.”** Think it far fetched? We've seen that the domestic legislation is already in place to take advantage of a crisis situation. In a break with the Constitutional limitations of the past, in the last several years the US government has asserted its rights to use the Armed Forces (not just the National Guard), - against American citizens. They've paved the way to take over the functions of government on every level in the wake of an emergency such as a terrorist attack. *‘But the terror is real’*, you argue. And so it is. The situation awaits only a government bereft of good intentions. And we must always remember the powers that sit behind the thrones: What are their intentions? Thus the stage is set!

So though the terror may come, we as Christians have nothing to fear. God anticipated terrorism. **“He who dwells in the secret place of the Most High Shall abide under the shadow of the Almighty...You shall not be afraid of the terror by night, Nor of the arrow that flies by day”**, - for great is our God! (Psalm 91:1, 5)

RUMBLINGS STILL

In Israel the rumors of war continue. Here are this week's offerings. The annual Israeli Intelligence Report was issued, warning of dangerous times in the months ahead. Besides the standing threat from Hezbollah, the constant rocket fire from Hamas-controlled Gaza and rumblings on the Syrian front, and the Iranian drive to acquire home-grown nukes; - the report cites a particular danger at the end of this month. That's when the Arab League summit will be held in Damascus. The intelligence community is on alert for dramatic action by Hamas and Islamic Jihad that may influence the meetings deliberations. This will be the first time that an Iranian leader will attend the confab, bringing with him more anti-Western / Israeli clout. This could signal an attempt to more fully coordinate the anti-Israeli alliance.¹⁷ The situation is further exacerbated by a report in a Turkish daily quoting a high ranking health official in Gaza. Dr Iyyad Sarrac warned that a chemical or nuclear assault is on the horizon. The Mental Health Program Director said that over one-third of even children report wanting to become martyrs for Islam. The doctor said “chemical weapons will enter Gaza and will be used against Israel.”¹⁸ This follows on the wake of fears that revenge attacks for the recent assassination of the Hezbollah leader will occur sometime late in March.

Jerusalem is taking all such threats seriously. The Jerusalem Post reports that Israel conveyed messages to Damascus through secret channels that Israel would strike Syria if Hezbollah launched an assault against Israel from Lebanon.¹⁹ Beginning on April 6th, Israel will conduct an unprecedented 5-day, nation-wide emergency drill to hone its response to the use of chemical, biological or nuclear weapons against its population.²⁰ The danger of war is that close. Even Syria officially acknowledges the threat of a war with Israel.²¹ And now Israel's putative peace partner, - Mahmoud Abbas and his *moderate* Fatah Party, are threatening a resort to terror again unless Israeli PM Olmert meets the Palestinians demand for more concessions by April, on borders, refugees, Jerusalem and water. That's the word that was passed along to Secretary Rice. To our shame, Vice President Dick Cheney's visit to the region is reportedly to put pressure on the Olmert government to give way more quickly to the Palestinian blackmail.²²

STAVING OFF ECONOMIC COLLAPSE ?

History tells us that in the period prior to the Great Depression, investors were buying stock on margin, - basically on unsupported credit and they got caught unable to pay when the bottom dropped out of the market. Today's crisis is similar in that many banks have made bad loans in the mortgage market. People can't pay and the bottom seems ready to drop out of that market. The Federal Reserve stepped in last weekend with an emergency stop-gap, making available cheap short-term loans so the nations financial institutions can stay afloat. In bigger news perhaps, JP Morgan Chase bought up former Wall Street powerhouse for a mere \$2 per share. The deal means that the Morgan interests, - (the same that are part of the Bildeberger cartel), - will now control even more of the banking market, - and bought for a song at that. The Federal Reserve (which you recall is a private banking cartel monopoly), - will guarantee \$30 billion in mortgages for one of its own. The low-ball price at which the stock was acquired perhaps reveals the depth of the danger that the entire market is in. The crisis threatens the viability of other "stand alone" investment banks.²³ The accumulated pressures are possibly setting the stage for further consolidation of economic power and not coincidentally, continuing the downward spiral in the value of the American dollar, making way for the proposed North American Union currency; - the amero.^{24 25 26}

That pressure is manifesting itself in several ways. Oil rose over \$111 per barrel on St Patrick's Day while gold moved to \$1,032.70 an ounce, further reducing the buying power of American consumers.²⁷ Meanwhile investors in oil rich Qatar and the United Arab Emirates are pulling out of dollars and buying into baskets of local currencies, - betting with their money on a looming dollar currency crisis.²⁸ According to reports, fear is spreading among the investor class on Wall Street. One British economist is even predicting a replay of a "1930s-like Great Depression".²⁹
