

WHOSE PALESTINE ANYWAY? – PART II

In the first part of this short series we looked at the history of the land that is now referred to as Palestine. Scripture and the historical record both conclude that there never was a nation called Palestine or a people called Palestinians. The record shows that the Arabs, without even a nod to this people that didn't exist, used every means possible to destroy the young nation of Israel. In fact, the Palestinians were instead an invention of the rabidly anti-Semitic groups grasping for an intellectual justification for their hate for Israel. As we find in today's installment, even the Arabs know, - and have admitted this to be true.

The Truth Comes Out

“To your descendants I give this land, from the river of Egypt to the great river, the Euphrates”. (Gen 15:18)

As we left off last time, we saw how Israel had defeated a second major coalition of the Arab nations that were gathering to effect her destruction. The IDF had secured the Golan, Sinai, the West Bank, and most importantly, Jerusalem. Israel was expanding closer to the borders that God had promised so many years before. It was these territorial losses that ironically inspired the Arabs to invent the national aspirations of the so-called Palestinian People. In reality, the Palestinians were just the ancestors of Arabs who had migrated to the Land beginning in the late 19th century. They are ethnically, historically, religiously and culturally the same as those living in Jordan; - the state created for them out of the old British Mandate. This was strangely acknowledged by Zahir Mushein, a member of the PLO's Executive Committee. (Remember: The PLO was ostensibly founded to pursue the rights and national aspirations of the Palestinian People. Here's what he told the Dutch newspaper Trouw back in 1977: “The Palestinian people does not exist...[A] Palestinian state is only a means for continuing our struggle against the state of Israel”. Mushein went on to cite “tactical reasons” for the creation of a ‘Palestinian People’. He finished his thought with this revealing statement: “...the moment we reclaim our right to all of Palestine, we will not wait even a minute to unite Palestine and Jordan”.¹

If you've noticed: The underlying theme of Arab / Islamic ideology is the complete destruction of Israel. They care not for the divisions of the land envisioned by past agreements. The founding documents of the terror group Hamas, now fighting in Gaza, of Fatah, the Palestinian Authority, Hezbollah and other nationalist-terror groups all call for the eradication Israel as a nation. The PLO's original charter admits in Article 1 that the: “Palestinian people are part of the Arab nation”.² Even Yasser Arafat, the founder of the Palestinian cause was by nationality Egyptian.

So here is the case in summary:

- Palestine was never a nation
- There never was an Ancient people called “Palestinians”
- Israel won the so-called Palestinian territories from Egypt and Jordan in a defensive war; - not from a never-existent ‘State of Palestine’
- The Arab states never thought to create a ‘Palestine’
- The Palestinians are ethnically Jordanian
- Jerusalem was never the capital of any nation but Israel
- There has been a continuous Jewish presence in Palestine until today; - even after the Romans forced most Jews out of the Land in AD 135

The fact is, as Dennis Prager points out: The Arabs want nothing less than the whole enchilada. At Camp David, Arafat rejected a settlement that would have given them their own state on 97% of the West Bank. It wasn't enough. They "don't want a second state. They want Israel destroyed."³ Shortly after the 1967 War with Israel, the united Arab countries offered Israel: "No peace, No recognition, No negotiations." They have not wavered since. The peace process is a sham. Even Arafat's Jerusalem representative called the Oslo agreements a "Trojan Horse". "We are setting an ambush for the Israelis and cheating them."⁴ They mean to have it all.

Though her neighbors say: "**Come...let us destroy them as a nation, that the name of Israel be remembered no more**" (Psalm 83:4), God has other plans! Passage after passage tells us that God sees Palestine as His land.⁵ All of it! And He has given it to Israel. Forever! "**Also I give to you and your descendants after you the land in which you are a stranger, all the land of Canaan, as an everlasting possession**". Simple like that!

FACISM WATCH

The world, - which had been holding its collective breath, - finally exhaled. Barack Obama had become the President of the United States. He is swept in to office on a tide of high expectations. Australia's Prime Minister Rudd called him "The hope of our time" and that country's Herald Sun ran an editorial entitled "America has its messiah". He is to bring, 'Change that we can believe in'!^{6 7} And so one of the first acts in that change, - came as an announcement that the US would again begin funding abortions in foreign countries. (Under Presidents Reagan and Bush, America had refused to hand over tax payer dollars to groups that performed or promoted abortions.)⁸ [*How proud we Americans must be, at the prospect of slaughtering more babies overseas!*] At the same time the President said that he intends to restore funding to the controversial UN Population Fund.⁹ Steven Mosher, President of the Population Research Institute, tells us clearly that the UNPF "misrepresents what it is about...[it] was set up in 1968 for the purpose of reducing fertility rates around the world". [*But after all, that is part of the agenda of the New World Order.*] Mosher goes on to describe how the Population Fund meddles in the morality of states across the globe, as they promote the expansion and legalization of abortion.¹⁰ [*You had better believe in that change!*]

Thus the New World Order is on the march again. Yet on the economic front, the new President seemed to be taking a course that was already set under the watch of President Bush. The plan being advanced is quickly, though somewhat imperceptibly, changing the way this country works. Over the last month US regulators effectively took control of Merrill Lynch, and became Bank of America's largest shareholder.¹¹ Now Bloomberg Financial is calling the added billions "with strings attached" being sent to Citigroup, - "nationalization by another name". One banker called it "de facto nationalization". Federal regulators there are dictating both policies and dividends.¹² [*This is a free economy?*] So it makes sense then that the President chose Mary Schapiro as head of the Security and Exchange Commission, a woman described as "one of America's most experienced regulators".¹³ [*Who better to run our free economy but the government?*]

You see, the central banking system which dominates global finance, has created - (intentionally or not) - a problem that they have told us can only be fixed by consolidating power in the hands of a few. Now the conditions on the ground are very real. The price of gold is going up, - not only against the dollar, - but against the pound and the euro too.¹⁴ Deflation is setting in, with prices dropping over 12% in the last three months alone.¹⁵ The head of JP Morgan tells us "The worst of the economic situation is not yet behind us".¹⁶ Nouriel Roubini, the NYU professor who nailed the nature and timing of last years financial crisis, says that the current banking system is "effectively insolvent" estimating losses could top out at \$3.6 trillion. Roubini points out the universal nature of the problem. It's affecting the US, Europe, the UK, Brazil, Canada, - the entire world.¹⁷ Britain's economy is

shrinking and the head of the Governor of the Bank of England is warning it may have to unleash “unconventional methods”; - meaning - effectively printing money, - expanding the money supply, - thereby devaluing its’ value.¹⁸ The UK’s Telegraph is raising the specter of “national bankruptcy”, and predicts it will bring “seismic” political impact where “anger will rage”.¹⁹

In some ways the rage has begun already, with riots breaking out in Latvia, Bulgaria and Iceland. Russia saw much the same thing in Vladivostock. Standards of living are falling across the globe and people are angry.²⁰ If you recall, it was just last fall that this newsletter carried the predictions of Gerald Celente, - another one who got the current crisis right. He told us to expect just such a lowering of living standards over the next several years. “America’s going to go through a transition the likes of which no one is prepared for”. According to Celente, the nation will work through a process of falling standards of living, homelessness, tax revolts and eventually a revolution, with Wall Street taking over the government in a “bloodless coup”.²¹ Now the economic crisis and resulting civil unrest in Iceland, - [not known as a hotbed of revolutionary fervor], - brought down the government in Reykjavik, forcing new elections. Yet another prognosticator with a stellar record, LEAP 20/20, - (they successfully called the fall of the Soviet Union- when that seemed really crazy) – believes that the world will face a major “tipping point” in March of this year. They also see the American government defaulting on its’ Treasury Bonds by the end of Summer. According to LEAP, that mega-crisis will offer opportunity: - a chance “conducive to the setting up of a new Dollar”.^{22 23}

Again, this is the very plan of the global elite. Former Fed Chairman Paul Volcker, unashamedly told the world, “A global economy requires a global currency” and “I fully support a global currency”.²⁴ The Father of the euro, Robert Mundell, believes “International monetary reform” will come only as the result of “the threat of a global crisis”.²⁵ And Zbigniew Brzezinski, a key Obama foreign affairs advisor has stated, “We cannot leap into world government through one quick step...The precondition for genuine globalization is progressive regionalization”²⁶ Is this then, opening the door to the introduction of the amero, - a currency designed for a North American Union of the US, Canada & Mexico? Such a union is the stated goal of Vincente Fox, the former Mexican President and the amero is planned to serve as the currency of the new EU-type arrangement. A North American Union under the auspices of something called the Security and Prosperity Partnership was a goal of the Bush Administration and its northern and southern neighbors since March 2005. The question then has always been how to make this pipe dream of the globalist elite palatable to the majority of the American public. Dr Robert Pastor, the godfather of the North American movement, believes he has the answer. He posits that another 9/11 type crisis could serve as the catalyst to “force democratic governments to make difficult decisions...required to create a North American Community”.²⁷ Understand this: That is the goal!

And it’s not just North America they’re after. New Age writers have long talked of a world divided into just ten centers of power, all working together in harmony. Then in 1974, Mesarovic & Pestel wrote *Mankind At The Turning Point*, fleshing out just such a plan. Over the next several decades we’ve seen that plan advance with the EU leading the way. Now there is a nascent South American Union, one in Africa, one forming among the Arab States, rumblings in Asia and of course there are American government agencies working with their counterparts in Canada and Mexico on forming a North American Union. Revelation 17:12-13 tells us that just such a world arrangement is on its way. **“The ten horns you saw are ten kings who have not yet received a kingdom, but who for one hour will receive authority as kings along with the beast. They have one purpose and will give their power and authority to the beast.”**

For its part however, the Obama Administration is moving more cautiously, – or perhaps stealthily, - than all that. The nominated Treasury Secretary with the tax issues, - the resident economic genius, - Timothy Geithner, has

signaled such high-handed possibilities as gold confiscation, bank holidays, dollar devaluation and mega-bailouts, could possibly be used to deal with the crisis. Gerald Celente believes that the drastic actions contemplated by the President, - the \$825 billion bailout for instance, - will only “worsen the credit crisis and severely damage the nation’s economic system”.²⁸ Former House Speaker Newt Gingrich put it well, “The Obama Presidency will be centrist in style but leftwing in personnel and policies.”²⁹ The Wall Street Journal’s Steven More, outlines what to him, - and me, - is Obama’s dangerous agenda. Here’s what he has to say about the keystone to the whole thing, the stimulus package. “The idea here is that if the government spends and borrows and prints nearly \$1 trillion we all get jobs and get rich. It’s the Bolivia economic model. Probability of passage 80%” Other highlights of his nightmares include “Hillary Care”; - the giant, overblown socialized medicine plan, - now being snuck in through the expansion of SCHIP healthcare for kids whose parents earn up to \$60,000 per year and the Cap and Trade \$1.2 billion energy tax hike. The SCHIP, it seems is being used as ploy to get the American public used to the idea of universal health care.³⁰

In the meantime, President Obama is proceeding with his plans to expand government on all fronts. And government is doing what government does; - feeding itself. And as government increasingly gains control, it continues to build up the fascist apparatus that is the necessary tool of the coming Antichrist.

ON THE TERROR FRONT

The War on Terror did not end the moment that new President Barack Obama took office. In the first days of his Administration the US military launched a missile attack against an al-Qaeda stronghold in Pakistan that killed 18, including 5 foreign terrorists. The strike was a continuation of missions inside Pakistan that began in August of last year.³¹ The strike followed on the heels of the President’s announcement that the US would be closing down the CIA’s prison in Guantanamo Bay, Cuba. A commission was given a year to come up with a plan dispose of the 250 inmates now housed there.³² Earlier, the President had ordered an immediate suspension of the trials of the Gitmo terror suspects, some of them suspected of being involved in 911.

Outright release, would seem more than a little crazy, given the history of those that had been released before. Just a couple of weeks ago the Pentagon let it be known that 61 former inmates of the facility had subsequently returned to a life of terror and war against the US.³³ [*As they say in the business: ‘Once a terrorist, always a terrorist!’*] Then just a week ago it was revealed that Said Ali al-Shihri, - likely involved in the bombing of the American embassy in Yemen, - and who had been released from the prison in 2008, - now showed up as the #2 man in al-Qaeda in Yemen.³⁴ [*It’s good to see that prisoner #372 is doing well with his American training!*]

So it seems the terror war is not over. Britain’s Sun revealed that at least 40 terrorists were killed in an Algerian training camp, - by of all things, - the Plague or Black Death; - that scourge of the Middle Ages that killed possibly over 70 million in a few short years in the middle of the 14th century. Terror expert Dr Igor Khрупinov believes that the al-Qaeda operatives were infected while trying to weaponize the disease for use against the West. “Al-Qaeda is known to experiment with biological weapons”, said he.³⁵
