

### **THE NEW ECONOMY**

January 27<sup>th</sup> I guess could have been called 'Pink Monday'. The pink slips were flying, - all around the world, as businesses throughout the globe began adjusting to the massive economic downturn. There were 70,000 layoffs in all.<sup>1</sup> The news in the days ahead didn't get any better. Here are some headline stories from just a few days later. Starbucks was closing 300 stores, Boeing cutting 10,000 jobs, Sony's profits down 95%.<sup>2</sup> Russian Prime Minister Putin referred to the unfolding economic panic as a "perfect storm", in a speech at the World Economic Forum in Davos, Switzerland.<sup>3</sup> And so it may be.

But not to fear, President Obama was last seen riding to the rescue with an \$825 billion stimulus package. But he was doing so with Democratic support alone, as all 188 Republican members of the House voted against the package. There is little that they can do at this point to slow down the Obama agenda. And so it passed, warts and all. Those warts included a provision for an invasive electronic data base that would collect the medical records of every American, including information on mental health, abortions, as well as legal and sexual information.<sup>4</sup> Then there was the provision that could provide possibly billions of dollars to ACORN, the leftist political action organization that is being investigated for massive voter fraud.<sup>5</sup> But even the Administration is starting to see that the stimulus and the already appropriated \$700 billion in bailout money might not be enough. That first installment has already been spread over 250 banking institutions with other money being spent on GM and Chrysler and AIG. Now according to some Obama folks, another \$2.1 trillion might be necessary to 'save the banking system'.<sup>6 7</sup> Many analysts see no end in sight to the bad news. The International Monetary Fund forecasts that the British economy will drop by about 2.8% in 2009. Japan is expected to go down about 2.6% while the US contracts by 1.6%. As many as 50 million jobs could be lost this next year.<sup>8 9</sup>

But you see, crisis breeds opportunity. Henry Kissinger, the former Secretary of State and member of the CFR, the Trilateral Commission and the Bildebergs sees that clearly. Here's what he told CNBC. "His task will be to develop an overall strategy for America in this period when, really, a new world order can be created. It's a great opportunity, it isn't just a crisis."<sup>10</sup> And that is just the stated agenda of so many world leaders today. France's Sarkozy and Germany's Merkel are both calling for a new international economic order that includes global financial regulation based on the UN Security Council. It's the rest of the world, - not America, - that may be calling the shots now. Referring to the upcoming worldwide economic conference this spring in London, Sarkozy said, "We'll take our decisions on April 2 in London. Perhaps the United States will join us in this change." Merkel sees the downturn as a chance to create "an international architecture of institutions".<sup>11</sup> What they are heralding is the end of the era of the hegemony of the Yankee Dollar. Klaus Schwab, founder of the forum at Davos, believes we "have to create a new world order". As reported in World Net Daily, he sees this economic slowdown as a "transformational crisis" making possible that very end.<sup>12</sup>

So just what would those opportunities look like? Perhaps it could signal the coming end of the dollar itself. Here's a headline from what I would describe as a fairly mainstream financial publication, *Market Watch*. "Uniting US, Canada, Mexico money could result from crisis" Author Todd Harrison announces early in the piece that "The New World Order is upon us". Then he goes on to describe the fact that governments are taking on increased risks. And he's right. But that's not free-market capitalism. That instead is something else; - Socialism, Fascism perhaps. It seems awhile back the Federal Reserve, - that nice group of international banksters with only our best

interests at heart, [*like stopping Depressions and keeping the economy running...ahem*] foresaw a crisis just like this one and wrote up a “solution paper”. [*Imagine! How could they possibly know just what was going to happen? I mean, what are the chances?*] The solution they came up with was what they called a “two-tiered currency”, - called by some, - The Amero. It would combine the natural strength of “Canadian natural resources, American ingenuity and cheap Mexican labor”. This idea of the amero being borrowed from Canadian economist Herbert Grubel who came up with the idea back in 1999.<sup>13</sup> Read the literature on this stuff, and you’ll find that many of the most influential bankers and economists are trying to move us toward a system of regional currencies that will eventually unite in one grand global economic system. So it was no surprise, that almost as if on cue, - Russia’s Putin called this last week for the end of the dollar as the world’s reserve currency. He told the summit in Davos that “The one reserve currency has become a danger to the world economy”, and went on to tout the utility of a system of ‘multiple reserve currencies’.<sup>14</sup> This is starting to appear to all be one big set up. Let me do some ‘*splaining*.

The powerful families behind the Federal Reserve are the one that have been benefiting from this crisis. These are the families behind the CFR, the Bildebergs and the Trilateral Commission. [*Oh, didn’t I just write the same thing about Henry Kissinger?*] Those families include the likes of the Rockefellers and the Rothschilds and the Warburgs, - and they are all avowed proponents of One World Government. And oh yeah, Henry Kissinger, - was and is a Rockefeller man. The whole apparatus is all about setting up this One World Government. And it’s getting so close now that you can smell it. Senator Barry Goldwater, in his book, *With No Apologies*, described well the work and intentions of just one of these organizations- and by association, the others. “The Trilateral Commission is intended to be the vehicle for multinational consolidation of the commercial and banking interests by seizing control of the political government of the United States. The Trilateral Commission represents a skillful, coordinated effort to seize control and consolidate the four centers of power - political, monetary, intellectual and ecclesiastical. What the Trilateral Commission intends is to create a worldwide economic power superior to the political governments of the nation states involved.”<sup>15</sup> Today, we are watching this appear before our eyes.

The current economic mega-crisis is providing the vehicle for moving mankind into this New Order. British Prime Minister Gordon Brown closely mirrored biblical language as he declared the situation to be but the “difficult birth pangs of a new global order”.<sup>16</sup> In describing the time that would precede the End of the Age, Christ warned His disciples of wars and rumors and famines and earthquakes and false christs; - a time of general turmoil, -and then said of all this, “**But all these things are merely the beginning of birth pangs.**” (Matthew 24:8) *Do you think He might be on to something there?*

## **IS THIS AMERICA ?**

I cannot tell you with what great sadness and disappointment that I write this story. The direction that this is taking is incredible, - and disturbing. And it altogether signaling the emergence of an America that I hoped and believed we would never see, but which may be emerging as we speak.

Let’s start with this fact. There has now been introduced into the House of Representatives a bill designated HR 645 that would authorize “National Emergency Centers” to be constructed on active or inactive military bases in order to provide “temporary housing, medical and humanitarian assistance” to American citizens, - in the case of “an emergency or major disaster”. Sound just like good sense preparedness? Well perhaps not quite. These would be FEMA facilities, - that’s the Federal Emergency Management Administration and therefore under the control of the Department of Homeland Security.<sup>17 18</sup> Still not concerned? Actually, by involving Congress this is just

creating a form of legal cover for FEMA camps and national security plans that have long been in place. Let's start with a little history.

Created in 1979, the stated purpose of FEMA is to "Reduce the loss of life" and protect the nation from terrorism, natural disasters etc, - and to assume control of "essential functions" in the event of "catastrophic emergencies". By 1984 the Miami Herald was reporting the existence of plans that called for the imposition of martial law in an emergency. FEMA led 34 other Federal departments in a rehearsal that practiced movement of civilian populations and the detainment of large segments of civilians. A refinement of the program came under the auspices of Operation Garden Plot,- (used in the 1992 Los Angeles riots), - that saw Army and Marine units operating alongside the National Guard to maintain order.<sup>19</sup>

As for the existence of camps themselves, they have long been the subject of reports in the alternative press. By the summer of 2002, the more mainstream NewMax had picked up the story that FEMA was working on "temporary cities" for use after a WMD attack.<sup>20</sup> Then in 2006 it was widely reported that KBR, (a subsidiary of Haliburton), had received a \$385 million contract to build detention centers to handle an 'emergency influx of immigrants' or 'new programs'.<sup>21</sup> Then add this. Just last year the Pentagon announced that a combat team from Iraq was to become part of "federal response force for natural or manmade emergencies and disasters, including terrorist attacks". This was to be the first installment, - according to the Washington Post, - of about 20,000 troops that would be stationed in the US for "domestic security" by 2011.<sup>22</sup> It's all part of a secretive martial law plan that has progressively taken shape over several administrations. Back in 2007 Congressman Peter DeFazio of Oregon, a member of the House Homeland Security Committee had been denied access to documents outlining the plan.<sup>23</sup>

While we might not be able to view the plan, by looking at the record of executive orders of the last several presidents we can get a pretty good idea of what it might hold. It seems FEMA has been set up as a kind of 'Secret Government' that will go into full operation when the next major attack or other natural or possibly even economic disaster producing civil unrest hits this country. Here are some of the powers that the Federal government can assume in the case of any declared emergency. Executive Order (EO) #10990 authorizes the Feds to take control of all modes of transportation. EO 10995 says it can seize the media. Another allows for control of farms and food resources. Others give the FEMA boys control of railways, public storage, to operate prison, to control energy resources, wages, credit and flow of money. FEMA is to take control of all other Federal Agencies as well as all state and local governments and law enforcement agencies. And EO #11921 says that the President can declare a national emergency of an undefined nature and that his action cannot be reviewed by Congress for six months.<sup>24 25</sup>

Here's the bottom line. The FEMA camps are already in place. They seem to be little more than thinly disguised concentration camps for enemies of the state. It is no secret that a collapse of the world economy is a very real possibility. Prognosticators like Roubini and LEAP 20/20 believe that the next big hit could come as early as March of this year. Some see a US default on T-Bills, - American bankruptcy by the middle of the year. This will bring sever dislocation, more layoffs, a depressing of the value of the dollar and opens the possibility of major civil unrest in this country. Food riots are a possibility. The Feds have put the pieces in place to deal with it. Recall that Nazi Germany used the suspension of civilian government to establish its murderous regime. The Illuminati have made no secret of their intentions to use and contrive crisis to bring about the establishment of a New World Order. Be aware! Beware! **"My people are destroyed for lack of knowledge"**. (Hosea 4:6)

## **'A KINDER, GENTLER' JIHAD**

There is a war being waged by Radical Islam that we know very little about. It is a war being fought in real courtrooms as well as in the more traditional way. Here are some of the battles being fought.

- Austrian politician Suzanne Winters is being investigated for correctly pointing out the Muslim-acknowledged fact that Mohammed had taken a 9 year old for a wife and drawn a connection to what she claimed to be “widespread child abuse by Muslim men” in her country. Sounds like a political statement to me; - and one whose wisdom can be a matter of debate. But in Austria it seems it is a chargeable offence. Winters now faces possibly 2 years in prison for the remarks in that it insulted Islam. She defended her remarks by saying, “We want neither Austrian or foreign paedodophiles”.<sup>26</sup>
- In the Netherlands the Amsterdam Court of Appeals ordered film maker and member of Parliament Geert Wilders to stand trial for “incitement to hatred and discrimination” for things that he *said* about the beliefs of Islam, - comparing some with those of Nazism.<sup>27</sup> His statements were deemed to be “insulting” and undermining the “religious esteem” of Islam.
- An angry mob of British Muslims chanting “Allah Akbar” drove off and chased more than a score of police for several blocks.<sup>28</sup>
- An official government report warned that Iranian-backed Hezbollah terror cells were being put in place throughout the US, and are now on the verge of becoming operational.<sup>29</sup>
- DEBKA reports that Lebanese Hezbollah has sent terror teams into six countries in the Middle East to conduct attacks against Israeli targets there. The threat is characterized as being “concrete, immediate and serious”. The counter-terrorism bureau is taking the warning seriously and is operating on an especially high-level of alert.<sup>30</sup>

## **CRAZY TALK ON THE KOREAN PENINSULA**

Going way back to the 1980's, it's been known that a nuclear confrontation in Korea was part of the plan by the Illuminati to bring about the New World Order. Peter Lemesurier wrote about this in his revealing best seller, *The Armageddon Script*. With that in mind, consider this piece of news that surfaced this last week. North Korea, inexplicably announced that it was canceling a non-aggression pact that it had with South Korea and claiming that it was on the “brink of war” because of the South's aggressive policies and statements. Of course, the part about South Korea taking an aggressive stance is patently ridiculous. North Korea is a backwards dictatorship that withholds food from their own populations, persecutes Christians there and has set up concentration camps to house its opponents. It recently acquired nuclear weapons and periodically threatens its neighbors with their use. According to the plan laid out in the *Armageddon Script*, a Korean nuclear crisis will “threaten the very survival of mankind” at a time when Israel and her Arab neighbors are engaged in all-out war, China is moving against Taiwan and the stock markets are crashing around the world.<sup>31 32</sup> According to the plan, these and other activities are to be engineered in order to bring the Antichrist to power. And yes, he does refer to AC in those very terms. [*Feels like we're getting close, doesn't it?*]
