SWINE FLU & THE DEPOPULATION AGENDA – PART III

The story of the Swine Flu is growing increasingly strange. We've seen how's there's evidence that it is a virus created in a laboratory. We've noted the very serious dangers found in the vaccines that are being prepared for use this fall. And we noted that one of the largest of the world's vaccine manufacturers, Baxter International, was found to have 'accidentally' shipped a vaccine containing the Bird Flu virus to 18 countries. So let's start taking a look at what might be behind this curious set of circumstances.

INTERESTING TIES

Here's where we're at. The United Nations is telling us that "Infectious diseases [are] spreading faster than ever". A worldwide epidemic "is only a few hours away".¹ This year it seems there is a full blown panic being orchestrated to pave the way for the mandatory inoculation of most of the world's population. The World Health Organization, it seems, is all about a general, universal, - and if necessary forced vaccination program for the entire globe. WHO claims the authority to forcefully inoculate, - (if necessary), - every citizen in all of its 194 member countries, - and that includes the US. America has been part of the worldwide plan to deal with a pandemic since 2005. As researcher Jane Burgermeister puts it, in the event of a declared pandemic, "special crisis committees would take charge of the health and security infrastructure of a country". In America this would be accomplished under the authority of both the Patriot Act, - (the anti-terror legislation that followed on the heels of 9/11), as well as the Model Emergency Health Powers Act. As of 2006, 37 states had adopted some form of the legislation.^{2 3} The legislation, which is ostensibly to protect the public from bioterrorism, is not coincidentally, - connected to attempts to set up a single payer health care system. The provisions are scary in themselves as they put in the hands of government a set of dictatorial powers, - *for the good of the people of course*. The Heritage Foundation outlines for us some of the 'model' provisions:

- "Force individuals suspected of harboring an 'infectious disease' to undergo medical examinations."
- "Track and share an individual's personal health information, including genetic information."
- "Force persons to be vaccinated, treated, or quarantined for infectious diseases."
- "Control public and private property during a public health emergency"
- "Mobilize all or any part of the 'organized militia' [National Guard] into service to the state to help enforce the state's orders."
- "Ration firearms, explosives, food, fuel and alcoholic beverages, among other commodities."⁴

All of this seems a bit over the top to combat a virus like the Swine Flu which so far has shown itself to be relatively mild in most cases. Yet we know that this is more than a pipe dream. A headline of the *Health Care Freedom Alliance* has found provisions in the proposed legislation that "*Will Fund State Vaccine Teams To Conduct 'Interventions' In Private Homes*".⁵ And section 1904 of the bill before the House of Representatives provides for home visits "to educate parents on child behavior and parenting skills".⁶ This is nothing less than a recipe for total government control. But to what purpose? Why would governments across the globe be interested in forcing populations to undergo under-tested vaccinations with built in dangers, and a dubious history of doing more harm than good? This is where it gets a bit crazy. We have to introduce the '*Kook Factor*'. The '*Kook Factor*' says that if you follow the evidence to its logical conclusion, - using only the facts and the very real words of very real and influential people - you will come to a conclusion - that despite all logic, - will make you seem like a Kook. *Even if it's true!!*

But here is some of the evidence we've uncovered.

- According to the official website of the Center for Disease Control (CDC) – the reconstruction of the Spanish Flu virus, - the H1N1 was fabricated in a government laboratory. Here’s a quote from their website. *“This report describes the successful reconstruction of the influenza A (H1N1) virus responsible for the 1918 “Spanish flu” pandemic”*.⁷
- Researchers have found that today’ Swine Flu has a “disturbing resemblance” to the Spanish Flu of 1918.⁸
- The vaccine manufacturer Novartis had a Swine Flu vaccine on the market before the first appearance of the Swine Flu in Mexico. It was patented seven months before the virus was discovered in April, - and curiously was recalled in February, - two months before the disease appeared!
- The World Health Organization board that recommended universal / global inoculations was packed with executives from the vaccine manufacturers such as Baxter and Novartis.^{9 10}
- Those same big pharmaceutical companies are the ones who are getting the huge contracts to produce the vaccines, - and getting oh so very rich in the process.
- Both the Rothschilds and Rockefellers [Illuminati / Bildebergs / CFR etc] have exercised incredible influence over the health and population policies of both national governments and international organizations.
- Baxter was caught distributing vaccines containing the live Bird Flu virus earlier this year. If it were not caught by local officials in Europe, it would have gone out to 18 countries and caused a pandemic.
- There is ample evidence that the vaccines are dangerous to say the least. The Swine Flu vaccine of the 1970’s produced numerous cases of paralysis.
- Squalene, an ingredient in the current vaccine has been linked to the manifold conditions of Gulf War Syndrome; - anything from fibromyalgia to forms of psychosis.
- The current recipes also contain mercury and other even more toxic components.

That’s just some of the evidence. It is no longer just some ‘crazies’ that are saying these things. Going all the way back to 1977, Jonas Salk of polio vaccine fame said, “Live virus vaccines against influenza or poliomyelitis may in each instance produce the disease it intended to prevent”.¹¹ Rick Martin who wrote *Depopulation of A Planet* back in 1995, concluded “None of the vaccines can confer genuine immunity. Often the opposite is true, the vaccine increases the chance of contracting the disease.” Then he noted that Medical historians had concluded that the Spanish Flu of 1918 “was solely attributable to the widespread use of vaccines”.¹²

Not coincidentally, the fear of the vaccine was what drove the Czech Republic, as it refused to be bullied by the World Health Organization to buy into their universal inoculation scheme. At this point they’ve declined to purchase the vaccine from Baxter International because of the safety issue. One government official was quoted as saying that the shots “may have side effects and it may even cause death if used”.¹³ So again the question arises: What’s the *WHY* behind the actions. That’s the subject that we’ll try to tackle next time.

WATCHING BIG BROTHER

The last couple of weeks have been a good stretch for ‘Big Brother’. The Bill of Rights is being slapped around these days in ways that make it hard for those of us over 50 to recognize the America we grew up in!

The grasping claws of the government are growing longer and longer. Last week we looked at how, under the pending healthcare reform legislation before Congress, “The federal government will have direct, real-time access to all individual bank accounts for electronic funds”.¹⁴ Think that’s scary? Well it gets even worse than that. Now we find out that in the *Cash for Clunkers* program, the DoT has claimed the right to access all information on the computers of car dealers that participate in the program. In fact it was claiming that all information on those computers became property of the United States government. That’s what the small print disclaimer called for when the dealers logged on, - and it was necessary to agree in order to go forward with the program. We first heard of this nonsense through Glenn Beck. Then my partner, Lynn Zankl went on the government’s cars.gov website to check it out and it was indeed true!

Here’s some of the language from the government website: *“When logged on to the CARS system, your computer is considered a Federal computer system and is the property of the United States Government. Any or all uses of this system and all files on this system may be intercepted, monitored, recorded, copied, audited, inspected, and disclosed to authorised CARS, DoT, and law enforcement personnel, as well as authorized officials of other agencies, both domestic and foreign.”*¹⁵

Then there's the healthcare debate; - or if the White House should have its way, - no debate at all. If you've been following, you've seen how the opposition to the proposed healthcare reform legislation is erupting at town meetings all across the land, in a real grass roots movement. Folks are angry at what they know about the bills before Congress, - and most times what they know is a whole lot more than the Congressmen know. You see, it seems the citizens have cheated. I know you'll find this both hard to believe and horrifying, - but in many cases, - unlike their elected representatives, - those citizens have actually read what's in the bill. Well not to be caught napping, the Obama administration has been proactive about ...ahem...stretching the interpretation of that pesky little right to free speech found in the First Amendment.

First of all, to stifle criticism, the White House called on good citizens, who came across "fishy" information, - or rather 'misinformation' about health care, - through say, their neighbors sending them an e-mail, - well they're to report that information to the White House. Here's how an official White House website put it. *"There is a lot of disinformation about health insurance reform out there, spanning from control of personal finances to end of life care. These rumors often travel just below the surface via chain emails or through casual conversation. Since we can't keep track of all of them here at the White House, we're asking for your help. If you get an email or see something on the web about health insurance reform that seems fishy, send it to flag@whitehouse.gov."*¹⁶

But I guess, - for the President and his cronies, - that just wasn't enough to stifle the debate. They believed it was necessary to control the discourse that was already occurring. So the President ramped it up even a bit more. He called in the unions. And the unions responded. The Democrat leadership began by painting the public opposition as angry "mobs". In claiming that what was being seen was somehow artificial and not a real movement of the people, Presidential spokesman Robert Gibbs referred to the "AstroTurf nature of so-called grass-roots lobbying". He also called them the "Brooks Brothers Brigade" as he tried to link this very real citizen anger over government hubris and control, - to the organizing orders of insurance companies.¹⁷ But the polls give the lie to that analysis. A Wall Street Journal / NBC poll found that Americans were opposed to the plan by a 42% to 36% margin. There were similar results in an NPR survey. The New York Times found that Americans believed that the plan would reduce the quality of their healthcare and increase their costs. Time found that large majorities of citizens believed that it would significantly raise costs, as well as complicate and reduce freedom to choose doctors and care. Finally, a Gallup survey concluded that: "A plurality of Americans believes a new health care bill will 'worsen' their health care and 'reduce' their access to care".¹⁸

That's about when the unions came in. AFL-CIO President Sweeney called in the troops. The Washington Examiner reports that an African-American conservative activist was assaulted with racial epithets, beaten and sent to the emergency room, that, - after presidential e-mails went out asking for union support and Obama's Deputy Chief of Staff vowed they would "punch back twice as hard" at opposition to nationalized healthcare.¹⁹ In the St Louis meetings, organizers locked out over 1,000 health care opponents while stacking the audience by sneaking SIEU Union members into the hall through a side door marked 'Handicapped'.²⁰ Tampa was also the scene of violent confrontations between union types and protesters.²¹ One group connected to the Obama administration, *Health Care for America Now* (HCAN), has even put together a primer on managing town hall type events in the future. They suggest making a "blanket rule" that no one can bring signs or leaflets and advertising this ahead of time: - then distributing only signs supporting the President's plan at the events for those that want them. Another tactic would involve the use of unofficial crowd marshals to control the crowd and eliminate or intimidate protesters that might disagree with the pro-nationalized health care agenda. HCAN is supported by such groups as ACORN, MoveOn.Org, Planned Parenthood and the racist, anti-Anglo La Raza.²²

Now add to this one last piece. If you recall, earlier this year, this newsletter reported on HR 645, a pending bill to authorize FEMA to build a minimum of six National Emergency Centers across the US. These would be old military bases, - just perfect for holding people. Some people see this as concentration type camps. Many view this as an attempt to "establish the infrastructure that could be used to house large numbers of political dissidents". OK, you say that that sounds crazy. Then just notice how the Army National Guard, through the GoArmy.com website, - is now advertising for "Internment / Resettlement Specialists". These would be responsible for running the camps. Here's a description of some of their duties: They are to provide "rehabilitative, health, welfare, and security to U.S. military prisoners within a confinement or correctional facility; conduct inspections; prepare written reports; and coordinate activities of prisoners/internees and staff personnel."²³ World Net Daily points out that a recent report by the Department of Homeland Security warned of "right

wing extremists” that needed to be watched;- including “those who support third-party political candidates, oppose abortion and would prefer to have the U.S. immigration laws already on the books enforced”.^{24 25}

At the very least, all of this can be taken as an orchestrated and purposeful attack on free speech and the rights of Americans to express their political will to advance a political agenda. Or it could be something much worse than even that. It could represent the CHANGE that we all should have seen was coming. I believe this is part of the remaking of America, and that if we do not wake up to the changes that are occurring we could lose the America that once was. Sadly, I must confess, that I believe that much of it is already gone. It is time to hit our knees. It is time to call out to our Creator; - to lay down our own agendas and causes, - and to take up His agenda and cause. There is yet hope, as expressed in the words of 2Chronicles 7:14; - **“if My people who are called by My name will humble themselves, and pray and seek My face, and turn from their wicked ways, then I will hear from heaven, and will forgive their sin and heal their land”**. It is time we humbled ourselves.

THE MAHDI IS COMING - THE MAHDI IS COMING

We know that President Ahmadinejad is promoting the return of the Islamic messiah called the Mahdi. The Mahdi is expected to return in the last days with an Islamic version of Jesus, who conquers Jerusalem and converts or kills Christians and Jews. Since 2004 something called the *Bright Future Institute* was established in Iran to hurry along the return of the Mahdi. A few years ago Ahmadinejad told us that Iran was preparing the way for his reappearance which was expected to ushered in through and during a time of chaos; - and the Iranian President offered to work toward bringing about that strategic chaos. Here are some offerings by Islamic scholars from recent conferences on Mahdism sponsored by *Bright Future* as quoted by Joel Richardson in World Net Daily. One participant offered that “there must be bloodshed and jihad to establish Imam Mahdi’s rule”. Another professor was even more forthcoming about conditions that would accompany the coming of Islam’s anointed one. “The Mahdi will offer the religion of Islam to the Jews and Christians; if they accept it they will be spared, otherwise they will be killed”. Some Islamic scholars make the case that the military expansion and the acquisition of nuclear weapons by Islamic states are necessary conditions for the establishment of the Mahdi’s rule, - which some sources tell us will be centered in Jerusalem for 7 years, - just like the Antichrist. Richardson quotes another speaker to describe some characteristics of that rule. “The Mahdi is a person who will appear before the coming of the Prophet Jesus, who will unite Muslims in the Islamic world, whose aim is love, who will take affection and compassion as basis, who seeks to eradicate all weapons from the world, who will disarm the world, who will eliminate all weapons from the world and build peace and brotherhood.”^{26 27 28} Want more on this subject? I make the case in my soon to be released book, *The History of the Future*, that the Antichrist of the Bible will indeed be the Islam’s Mahdi.

THE RECESSION IS OVER...??

Let the parade begin! Buoyed by a 44% surge in the stock market since March, some economists and Newsweek and ABC have declared that the Recession is over, kaput, fini!! *But it ain’t necessarily so.* First of all here’s the explanation given by one economist in the Newsweek story. “But when economists proclaim a recession over, they’re celebrating a technicality: they mean economic output has stopped contracting. And while that is good news, you might wait a while before adding Judy Garland’s rendition of ‘Happy Days Are Here Again’ to your iPod.” But there are dissenting voices. Economist Dean Brown foresees that unemployment will cross “10 percent this summer and likely crosses 11.0 percent early next year”. *That’s one heck of a caveat, if you ask me. Especially since the ‘real’ unemployment rate is actually much higher.*^{29 30}

And there are concrete indications that things may not be going quite that well. Analyst Bill Fleckenstein of MSN Money argues that Fed policies have made inflation, - perhaps even hyperinflation, - almost inevitable.³¹ The Federal Reserve is creating the very conditions for such a phenomenon by buying up US debt, - earlier this month again, - to the tune of a cool \$14 billion. They tried to hide the thing by first selling the 7-year bonds to foreign investors, and then purchasing nearly half of it back from those same buyers just ten days later. [*Oh what a happy coincidence that is!*] And they paid for it by...PRINTING THE MONEY. Now that creates what Columbia’s Professor David Buckner called an “artificial infusion of cash” that will have to be accounted for someday, - through taxes or inflation. One way or the other the government will have to get the money to pay for our new toys, - whether they be *Cash for Clunkers*, or Stimulus, or bailout, or Government Healthcare or buying up our own debt with *play money*. And Treasury Secretary Geithner has signaled that the spending spree is not over. He’s asked Congress to up the Federal debt limit. We’ll hit the current one sometime in October.^{32 33 34 35}
