### SWINE FLU & THE DEPOPULATION AGENDA – PART VI

**“And then shall that Wicked be revealed...whose coming is after the working of Satan with all power and signs and lying wonders, And with all deceivableness of unrighteousness in them that perish; because they received not the love of the truth, that they might be saved.” (2Thessalonians 2:8, 9-10)**

*Through each installment of this series we have lifted the veil a little more; - revealing a bit more of the true nature of the enemy that we face. Our vision will be a little imperfect until He comes. “For now we see through a glass, darkly”. (1Corinthians 13:12) Yet our God has promised us that His Holy Spirit will guide us “into all truth”. (John 16:13) So let’s go forward with confidence! Last time we delved into the role that religious belief’s has played in the promotion of a ‘population control agenda’. Next we’ll look at just how this is beginning to unfold in real time.*

#### A TIME FOR ACTION

“We are parasites...Nature would be much better off without us.” (*Ecofeminism* author and theologian Rosemary Radford Reuther)<sup>1</sup>

“If I were reincarnated I would wish to be returned to earth as a killer virus to lower human population levels.” (Prince Phillip, leader of the *World Wildlife Fund*)<sup>2</sup>

Here’s how Doc Marqis, - a former Satanist, - would characterize it as related by the Cutting Edge’s David Bay. [T]he Illuminati never, ever does something on a large scale unless they have carried it out – tested it – on a smaller scale first”.<sup>3</sup> This could certainly be the time of testing; - of putting things in place. Governments across the world are gearing up to vaccinate large swaths, - (or in some cases, all) – of their populations. Washington is preparing to inoculate about half within just several months, - but despite reports to the contrary are remaining adamant that the shots will be voluntary.<sup>4</sup> However the government will certainly have an array of powers to enforce their will on the populace, should they encounter significant opposition. And that opposition is forming around the globe. About half the GPs in Great Britain said that they will refuse the shots, though they are “first in line” to receive them and though they will be the ones administering the vaccines to the general populace.<sup>5</sup> An AP story tells us that about half of Hong Kong’s health workers will do the same.<sup>6</sup>

But governments may not just take that lying down. As the Christian Science Monitor warns us: “In the event of a health crisis, the federal government has broad powers”. Those include banning public gatherings, restricting movement or forced vaccinations, - perhaps even quarantines backed by marital law.<sup>7</sup> The Massachusetts Senate has recently passed a bill that would compel individuals to be quarantined should they refuse the shots. Would that mean at home, - or – in some government designated location?<sup>8</sup> Paul Joseph Watson in Prison Planet warns us that authorities are preparing if necessary to “seize children from schools” to deal with this very dubious

health threat.<sup>9</sup> And recently a story broke that Verichip is working on an implantable microchip capable of the swine flu and other viruses in a person's bloodstream.<sup>10</sup>

So what's behind all this? Well we began this series several weeks ago with a quote from a former Bush-1 official who believed that there was in certain quarters, - an actual agenda to reduce the world's population by whatever means necessary. Now, Ghislaine Lanctot, a Canadian doctor and author of *Medical Mafia*, is joining that growing chorus. She holds that the Swine Flu is "a pandemic concocted and orchestrated by the WHO", in the service of "military, political and industrial interests". Whether in this round or at some future date, the "elite...will introduce a compulsory vaccination that will contain a deadly virus"...a eugenics weapon for "massive and targeted reduction of the world population". Even the Center for Disease Control admits that the 1970's Swine Flu outbreak originated out of the government facilities at Fort Dix, NJ. Sadly, this is not the only instance of new diseases appearing with connections to labs and other government facilities. Here is a damning quote from an article by Kurt Nimmo that appeared in *Infowars* in July of 2009. "According to a source known to former NSA official Wayne Madsen, 'A top scientist for the United Nations, who has examined the outbreak of the deadly Ebola virus in Africa, as well as HIV/AIDS victims, concluded that H1N1 possesses certain transmission "vectors" that suggest that the new flu strain has been genetically-manufactured as a military biological warfare weapon.'" Add to that the thousands of missing virus samples from a US Army facility that investigates infectious diseases. Earlier we covered the lawsuit filed by Jane Burgemeister that both the Bird Flu & Swine Flu viruses were the product of bioengineering in labs funded by the World Health Organization.<sup>11 12</sup> Then consider the fact that over a million Gulf War veterans are already dead or disabled, - so many afflicted with Gulf War Syndrome. There are ties to both vaccines and the fact that the US may have "blasted thousands of tons of nuclear waste" into the combat zone during the war.<sup>13</sup>

There is in fact a terrifying connection between the Pentagon's chemical / biological warfare programs of the defeated Germans and Japanese after World War II. After the fall of Germany, - and before the Japanese had even surrendered, - the OSS, - forerunner of the CIA, - was importing German scientists into the US to work in the American military establishment. Some were even "saved from the gallows" of Nuremberg, and took positions in the US Army Chemical Corps or aiding in the development of bacteriological weapons. After Japan surrendered, amnesty was extended to members of the Empire's Unit 731. This unit was involved in testing "prisoners with plague, cholera, smallpox, botulism and other infectious diseases. Their work led to the development of what was called a defoliation bacilli bomb and a flea bomb used by the Imperial Army to spread bubonic plague across unoccupied areas of China." Its members were brought to the states to work on the same sort of programs; - designing weapons that today would be called WMDs. They had been working on these for their Axis countries during the course of the War. Over the course of time the US military began to test those weapons, - on unsuspecting civilian populations - in America itself. In 1950 the Navy was tested a microorganism that likely claimed a dozen elderly victims. In 1951 Army researchers "deliberately expose[d] African-Americans to the fungus *Aspergillus fumigatus* to discern whether they are more susceptible to infections caused by such organisms than white Europeans". In 1955 the CIA tested a bio-weapon in Tampa causing a "sharp rise" in the incidence of Whooping Cough and another dozen deaths. The list goes on and on. In 1999 there is evidence that the appearance of the West Nile Virus can be traced to a research facility on Plum Island. Documented incidents, - (though often officially denied), - continue almost right up to the present day.<sup>14</sup>

The prestigious *New England Journal of Medicine* reported that Mosquito testing in Florida was behind an early outbreak of chronic fatigue syndrome. More mosquito tests in Ontario through Queen's University led to

outbreaks of chronic fatigue syndrome and other conditions. Overtime the Pentagon was involved in the creation of a bio-warfare “disease agent” called mycoplasma. Many researchers point to the role that this material played not only in the diseases mentioned, - but also its connection to the AIDS virus. They allege that both the CIA and the National Institute of Health were out to develop a “deadly pathogen for which humanity had no natural immunity”.<sup>15</sup> Sound crazy? Well then process this. In 1970 \$10 million was allocated in HB 15090 - the appropriations for the Defense Department to produce within 5 to 10 years “a new infective microorganism which could differ in certain important aspects from any known disease-causing organisms. Most important of these is that it might be refractory to the immunological and therapeutic processes upon when we depend to maintain our relative freedom from infectious disease.” By 1987 the Times of London trumpeted a headline reading “WHO murdered Africa”, in which it claimed that the “smallpox vaccine triggers” the AIDS virus. Over 90 million black-Africans were vaccinated under the auspices of the World Health Organization. What’s interesting is that the AIDS virus developed “simultaneously in Africa, Haiti, Brazil, the United States and southern Japan”. Dr RJ Biggar, writing in the British medical journal Lancet, concluded that “The AIDS agent... could not have originated de novo”, - or out of “thin air”. There is much evidence that the AIDS virus was in fact, - laboratory produced. The fact is, AIDS did not exist in Africa before the onset of the UN’s vaccination program. And a vaccination program was implicated that linked hepatitis shots with the transmission of the condition. Even the CDC admitted in 1984 that 60% of those that received the hepatitis vaccine were infected with aids. With this increasing evidence, AIDS seems to join a list of likely man-made diseases; - such as Gulf War Syndrome, and the latest round of flu – the H1N1.<sup>16 17 18</sup>

Dr Stanley Monteith looked at the purposefully ineffective public health measures with which the authorities were combating HIV, and the UN / WHO support of massive abortion programs through “family planning” and came to the conclusion that it was all part of “population control” a “‘master plan’ to kill off large segments of the world’s population”. And there were other means being used. Throughout its early years, DDT was known as the “safest pesticide known to man”. It was used to control the “spread of insect-borne diseases”, and was responsible for saving , - according to the National Academy of Sciences no less, - 500 million lives through malaria control. But in 1972, William Ruckelshaus, - head of the EPA, - acted against sound scientific advice and outlawed its use. As Monteith puts it: By doing so “he signed the death warrant for hundreds of millions of helpless human beings”. One of the scientists who campaigned to ban DDT once said, “People are the cause of all the problems. There are too many of them. We need to get rid of some of them and this is as good a way as any”. He went on, finishing with this racist comment. “It doesn’t really matter...most of them are Mexicans and Negroes.” Dr Monteith estimates that when we discontinued using DDT, it cost the world perhaps 600 million lives.<sup>19</sup>

But perhaps the most shocking revelation of the ‘Elite’s’ willingness to use any and all means to achieve their ends can be found in National Security Council Memorandum 200, drafted in 1974, under the august and honored Secretary of State, Dr Henry Kissinger. This was during the administration of President Gerald Ford. The ‘Memorandum’ identified 13 key countries which if allowed to grow too much could turn into a threat to the security of the nation. These included India, Pakistan, Bangladesh, Turkey, Mexico, Brazil Columbia and others. So how to deal with this? Kissinger’s panel was looking for ‘population-reduction programs’. So start with birth control. And then target the food supply. If you control the amount of food available to a population, - you control its ability to grow. The US should be willing to look at a nation’s compliance with birth control and other measures when it determines the amount of food aid that it would make available to a starving people. Yet in the process it must “...avoid the appearance of coercion”. The report goes on to ask this morally loaded question.

“Is the U.S. prepared to accept food rationing to help people who can't/won't control their population growth?” Kissinger's group seemed ready to answer that question in the affirmative, predicting “large-scale famine of a kind not experienced for several decades—a kind the world thought had been permanently banished”.<sup>20 21</sup> Dr Kissinger remains a key Rockefeller man, member of the Illuminati, involved in the policies of the Bildebergs and very influential in many areas, - including food policy. Here is a quote, seemingly reflective of the good Dr Kissinger's philosophy. “*The illegal we do immediately. The unconstitutional takes a little longer.*”<sup>22</sup>

## **THE SMELL OF PEACE**

The Israeli paper Arutz Sheva is carrying a story that President Obama will present a peace plan for the Middle East that would see the Temple Mount come under full Arab sovereignty. According to the Saudi newspaper Al-Ukaz, Mr Obama will present a blueprint for Palestinian State under Palestinian Authority control, to be in place no later than 2011. The story says the plan will be unveiled at UN General Assembly meeting to be held in late September. It includes an international (peacekeeping?) presence in the region.<sup>23</sup> This supposed Obama plan coordinates nicely with what some major Arab players had to say on the subject. Egyptian President Hosni Mubarak called for a peace that would see a Palestinian state and comprehensive peace, - before and not after, - a comprehensive peace that would see the creation of a national homeland for the Palestinian people. In return he seemed to offer to bypass the issue of Israeli settlements in Judea and Samaria (the West Bank).<sup>24</sup> And Prime Minister Fayad of the Palestinian Authority called for a plan that would “establish a de facto state apparatus within the next two years”.<sup>25</sup> In the past the President has always seen the peace process as centered around a return by Israel to the borders that it held before the onset of the 1967 War.<sup>26</sup> Now according to Haaretz, the process will begin with a renewal of talks beginning with a trilateral summit involving the heads of state; - President Obama, Prime Minister Netanyahu and President Abbas of the Palestinian Authority. Israeli President Shimon Peres confirmed that arrangements were in process for such a summit to be held ‘on the sidelines of the UN General Assembl’ to be held later this month.<sup>27</sup>

Meanwhile, concern is growing on the Iranian front. Reports are surfacing that Iran is less than a year away from being able to produce its own homegrown nuclear arsenal. (As reported here before: Elements in both the American and Russian military & intelligence communities believe that the Iranians already possess some limited nuclear capabilities which they bought ‘off the shelf’ on the black market after the fall of the former Soviet Union.) With its current, tested missile arsenal, the Iranians could effectively target Israel, southeastern Europe and American bases in the region.<sup>28</sup> The US and Israel have been frustrated by the actions of Mohammed El Baradei, head of the UN's nuclear watchdog, - the International Atomic Energy Agency; - who, - according to them has refused to publish evidence provided by Western intelligence agencies that would implicate the Iranians. The evidence shows that Tehran has been running a covert, military nuclear program, parallel to its more public civilian one. Now those countries, - along with Britain, France, Japan and the Netherlands, are negotiating on just how to release the damning information. They may publish the information via Iranian exile organizations.<sup>29</sup> More concretely, the US Air Force is speeding up delivery of more than a dozen bunker-buster bombs which would be used in any attack on the hardened silos used to house the Iranian nuclear program.<sup>30</sup>
