### CONSPIRACIES & REALITIES – PART I

*I first saw the story that sparked this a little over a week ago – and though interesting, I immediately assigned to the 'Kook File'. That's reserved for those items that I believe may have some validity – but just don't meet the 'pedigree' muster of the other stories covered. [It was from The Examiner, after all, and they carry all that UFO stuff. And while I don't dispute that something is happening in UFO Land - and have built a strong case for a demonic / Nephilim connection a la Genesis 6...well I just didn't want to go there.] But after some further research – a light bulb went on. The claims of a plan for the imminent creation of World War III and the culture-redefining chaos that would ensue were strangely similar to published Illuminati plans that we've covered before. So before you relegate this to the 'Kook File', keep an open mind and take a look as we examine the evidence. Sometimes 'Conspiracy' and 'Reality' can both be operating!*

#### A PLAN FOR THE HERE & NOW

**“The kings of the earth set themselves, and the rulers take counsel together, against the LORD, and against his anointed, saying, Let us break their bands asunder, and cast away their cords from us. He that sitteth in the heavens shall laugh: the LORD shall have them in derision.”** (Psalms 2:2-4) (KJV)

Peter Lemesurier, author of *The Armageddon Script*; the 1980's Illuminati tome that reveals a cogent plan to bring about the New Age, probably said it the most clearly and succinctly. “If the Messiah is to appear, then he must be produced.”<sup>1</sup> In that work, Lemesurier goes on to outline a very human plan to create the controlled chaos necessary to force the creation of a One World Government under the leadership of a messiah figure who will simulate the fulfillment of Biblical and other religious prophecies to achieve the New World Order. That was 1981 – and much of what was written about has followed the plan and the pieces are in place to achieve their goal – which was scheduled for right about now. Now enters some new information that fleshes out many of these earlier plans and offers a frightening view of the events of the last several years in the context of that plan. According to these new revelations, the PTB (Powers-That –Be), - or in the words of the revelator, the “Over-Government”, are maneuvering to set events in motion to fulfill their goals within the next couple of years.

Bill Ryan is a respected researcher on the coming New World Order and the author behind *Project Camelot*. Back in January of 2010 he interviewed a man that will remain anonymous. Bill claims that he thoroughly vetted his subject for authenticity and that he is authentically who claims to be; - which is retired British military, (involved with the missile program), and a senior executive in the City of London. City of London is shorthand for the UK equivalent of the very center of the Wall Street financial power, - and is arguably considered in some circles to be the real center of the globe's finances. Back in 2005 he attended a meeting of Senior Masons in the City of London. At the meeting the British military guy, who Ryan refers to as W (for witness) in the transcript, outlined what he heard, much of which was outlandish beyond belief – especially in the casualness with which some subjects as nuclear war and the slaughter of billions of souls through biological weapons – were referred to by dozens of ‘insiders’ that seemed to be ‘in on’ the plan. These were not the decision makers – for the most part – but were more at the operations level, carrying out decisions that had had long ago been decided. W did say that there were some senior officials present, big-wigs from the Conservative

Party, and high ranking members of the Church of England. Because of his position he was assumed to be part of the group that was ‘in the know. It was the one and only meeting that he attended. According to Ryan, driven by conscience, he is now coming forward to warn the world of what is on the near horizon. [Recall, that we are only giving this credence because it coincides with previous information.]

W asserts that all the preparations are already in place. A major part of that preparation was the financial collapse of October 2008. We’ve noted here before that the entities that ‘made out’ when all the government money was being thrown around were those that were ‘connected’ to the international banking and finance houses throughout the globe. Even when paper losses were being absorbed it was resulting in a stronger control of the market by Illuminati bankers. W put it like this, the financial collapse was merely the “centralization of financial resources.” It is all part of a scenario being worked over many generations. Even World War’s I & II were a part of the plan. Here are Bill Ryan’s bullet points of the most important points in his exhaustive interview with W.

- *“There is a planned Third World War, which will be nuclear and biological. Our source believes that this is on track to be initiated within the next 18-24 months.*
- *It is planned to begin with a strike by Israel on Iran. Either Iran or China will be provoked into a nuclear response. After a brief nuclear exchange, there will be a ceasefire. The world will be thrown into fear and chaos - all carefully engineered.*
- *The extreme state of tension will be used to justify heavy social and military controls in all western first world nations. Plans are already in place for that.*
- *During the nuclear ceasefire, there is planned to be a covert release of biological weapons. These will initially be targeted against the Chinese. As our source chillingly told us, "China will catch a cold". Biological warfare will spread further, to the west. Infrastructure will be critically weakened.*
- *This is intended to be just the beginning. After this, a full nuclear exchange would be triggered: the "real" war, with widespread destruction and loss of life. Our source tells us that the planned population reduction through these combined means is 50%. He heard this figure stated in the meeting.”*

Oh yeah, and one more thing. They’re doing all of this in anticipation of a massive “geophysical event” that will affect the entire globe. The outworking of this plan is all to ensure that the PTB, (the Anglo-Saxon Illuminti) will be in charge when the smoke clears. And there’s more, but that will have to wait. We’ll pick this up again next time.<sup>2 3 4</sup>

## **ISRAEL: ON THE CUSP OF SPRITUAL REVIVAL ?**

**“The hand of the LORD came upon me and brought me out in the Spirit of the LORD, and set me down in the midst of the valley; and it was full of bones. Then He caused me to pass by them all around, and behold, there were very many in the open valley; and indeed they were very dry. And He said to me, ‘Son of man, can these bones live?’ So I answered, ‘O Lord GOD, You know.’”** (Ezekiel 37:1-3)

Ezekiel 37 is a key chapter in understanding the timing of the coming of Messiah. It is a sure prophecy of Israel’s coming together – in the beginning in spiritual bankruptcy – and the miraculous work of God of not only calling it into an earthly existence – but giving it a true spiritual identity. That’s why the words of Prime Minister Benjamin Netanyahu, speaking on the 65<sup>th</sup> anniversary of the liberation of the Nazi death camp at Auschwitz are interesting indeed. He said, *“Armed with the Jewish spirit, the justice of man, and the vision of the prophets, we sprouted new branches and grew deep roots. Dry bones became covered with flesh, a spirit filled them, and they lived and stood on their own feet.”*<sup>5</sup> Is it odd that the

country's chief would speak of spiritual revival in a time of existential danger on many fronts? Is it strange that a political operator like Netanyahu would claim the fulfillment of ancient prophecy? Perhaps not!

Critics have offered that many of Bibi Netanyahu's moves are motivated by a desire to please the Christian Zionist movement in the West – in order to keep US support flowing – especially in the wake of a not-so-friendly Obama presidency. But Bibi's claim of an ongoing spiritual transformation is confirmed from the unlikely lips of Israel's left-leaning President Shimon Peres. *“I think there exists a great call for a Jewish spiritual revival and re-moralization against the dangers we face...We remain as old as the Ten Commandments and as innovative as nano-technology.”*<sup>6</sup> He might not have meant it in the same way as Netanyahu...or say the Bible, but I believe he senses something just the same. In this time of roaring messianic expectations, - in Islam, as well as among Christians and Jews – and New Agers and Neo-Pagans for that matter, - even the secular are infected by the notion that something bigger is going on here. And they are right. We may be on the verge of THE singular prophetic event of all time.

Let's return to Ezekiel. **“Again He said to me, ‘Prophecy to these bones, and say to them, ‘O dry bones, hear the word of the LORD! Thus says the Lord GOD to these bones: ‘Surely I will cause breath to enter into you, and you shall live. I will put sinews on you and bring flesh upon you, cover you with skin and put breath in you; and you shall live. Then you shall know that I am the LORD.’”** (Ezekiel 37:4-6) God is promising to infuse Israel – His own people – with the very **“breath”** of His Holy Spirit. Look at verses 11 through 14. **“Then He said to me, ‘Son of man, these bones are the whole house of Israel. They indeed say, ‘Our bones are dry, our hope is lost, and we ourselves are cut off!’ Therefore prophecy and say to them, ‘Thus says the Lord GOD: ‘Behold, O My people, I will open your graves and cause you to come up from your graves, and bring you into the land of Israel. Then you shall know that I am the LORD, when I have opened your graves, O My people, and brought you up from your graves. I will put My Spirit in you, and you shall live, and I will place you in your own land. Then you shall know that I, the LORD, have spoken it and performed it,’ says the LORD.”**

For almost 1,900 years Israel was without Temple or home, only a remnant remaining in the Land. Yet God has fulfilled His promises as recorded by the many prophets. He called them into the Land of His promise and restored them as a nation. Now in this time of critical danger to the very existence of the state, He is stirring them to spiritual renewal. Is Bibi correct that Ezekiel 37 is now fulfilled? Perhaps! Or perhaps he is sensing those first stirrings. But we do know this: The buds are on the tree. And we know that once Ezekiel 37 and Israel's spiritual revival is realized – chapters 38 & 39 will shortly follow. Those passages talk of the Gog / Magog invasion of Israel in the Last Days. It will be led by Persia, along with certainly Turkey and possibly Russia along with – certainly again - Libya and Ethiopia and the former Soviet Islamic Republics. It's all setting up now...for anyone that cares to watch. The prophetic shadows are casting forward as we watch God's plan unfold.

## **THE IDENTITY OF JESUS – PART VI**

*We have reviewed the witness of fulfilled prophecy and history and the claims of His followers and of Christ Himself. But what of the many miracles attributed to this man from Galilee? Are these but legendary? Or could they be real evidence of the Divine?*

### **MIRACULOUS EVIDENCE**

This brings us to another compelling form of evidence for the divinity of Christ, his miracles. As noted by the testimony of Nicodemus, and the attitude of the authorities, the fact that Jesus could perform healings and signs was never challenged by his enemies. Having just witnessed the healing of two blind men and the casting out of a demon from a mute, they were amazed and challenged instead the source of his power. **“Nothing like this has ever been seen in Israel...It is by the prince of demons that he drives out demons.”** (Matthew 9:28-33) Searching the ancient records, it was not unknown for rabbis to be able to perform exorcisms, or even successfully pray for rain. But it was the nature of

Christ's miracles that set him apart. As we have seen when he walked on the water and calmed the raging storm, nature itself responded to his commands. The very order of his miracles was greater than any performed by those other Rabbis. Jesus healed the blind and the deaf, caused the lame to walk, multiplied loaves and fish, and raised the dead. Furthermore he did it all on his own authority.<sup>7</sup> But miracles such as these did not go unpredicted. In fact this is just further evidence of Jesus' Messianic identity. In Isaiah 35:5-6 it is written, **"Then will the eyes of the blind be opened and the ears of the deaf unstopped. Then will the lame leap like a deer, and the mute tongue shout for joy."**

These miracles were not questioned at the time. In fact they were among the most important tools used by the Apostles in the early spread of Christianity. In his address to the crowds on the first Pentecost, Peter relied on the very fact that the miracles of Jesus were well known and accepted to make his case. **"Men of Israel, listen to this: Jesus of Nazareth was a man accredited by God to you by miracles, wonders and signs, which God did among you through him, as you yourselves know."** (Act 2:22) *"As you yourselves know."* The miracles of the recently crucified Christ could serve as a tool only because they were so widely known and accepted by the populace. Jesus' miracles were not denied by his enemies because they could not be. They were performed in public before believers and non-believers alike. And amazingly they demonstrated a wide mastery over the forces of nature. Jesus not only healed the sick and the lame, but also calmed the storm, fed the multitudes, and raised the dead. His was an overwhelming demonstration of divine power. That is what it was intended to be. Yet those miracles were always performed with an end in mind. Jesus repeatedly refused the demands of the crowds to perform a sign as a form of entertainment or to satisfy their curiosity. In fact such demands for a sign always seemed to come on the heels of some great miracle just performed. In the 12<sup>th</sup> chapter of Matthew we are told of an exorcism Jesus performed on a man, restoring at the same time his ability to see and to speak. Hearing of this the Pharisees did not question the miracle but instead attacked him for tapping into the power of Beelzebub to cast out demons. Later they demanded a miraculous sign. But Jesus refused to play their game. Instead he rebuked them for the disingenuous of their request. Like the atheist who has determined that no amount of evidence could ever convince him of the possibility of the supernatural, the Pharisees were impervious to any weight of proof. To admit that Jesus was the Messiah would have challenged their position and undermined their authority.

Miracles were the signs that Christ used to validate his case, demonstrate God's love, and give glory to the Father. They were always an expression of spiritual truth, never to gain the approval of the crowd or any personal advantage.<sup>8</sup>

Now there are critics out there who will claim that the miracles of Jesus were an invention of the Gospel authors. They begin with a totally mechanistic view of nature. Their argument goes something like this; *Miracles are impossible because they violate the laws of nature. The Gospels contain accounts of miracles. Therefore we can't trust the Gospels in this matter. If we can't trust the Gospels then we have no reasonable evidence that the miracles ever occurred.* Of course this is circular reasoning and against the evidence we have for the reliability of the Gospels.<sup>9</sup> Again we know two facts about the existence of miracles. The teachings of Christ, that relied so much upon the reality of the miracles to validate it's message, were being broadcast to the populace less than two months after his execution on the day of Pentecost. Eyewitnesses to the contrary would surely have fatally wounded any effort to spread the new belief. Instead at the very first teaching by the Apostle Peter, three thousand people came to believe in Jesus. This would not have been possible in Jerusalem if the miracles of Christ were not well known. Secondly, Jesus' closest disciples, the witnesses to so many of the wonders, ultimately gave their lives as testimony to the truth of those teachings. They fully believed, and they were in a position to know.

It all comes down to the supremacy of God. If an all-powerful, creator God exists, then miracles become imminently possible. We must follow where the evidence takes us. It has brought us a long way thus far. We have been led to the existence of God by the very real presence of the moral law, and by the very fact of our existence. The unbelievably complex design of our universe and all of its component parts confirm this for us. We have been led to the God of the Bible by the inexorable logic of the existence of evil and sin and the need for atonement that that entails. The demonstrated reliability of that book and the fulfillment of its prophecies have confirmed this. The evidence has taken us to the threshold of the divine. An all-powerful God, existing outside of time and space; one responsible for the creation of

the universe with all its natural laws would have no problem with the miraculous. These natural laws are not the problem. To quote Paul Little in *Know Why You Believe*, “Natural laws do not cause anything in the sense that God causes and creates. These are merely descriptions of what we observe to be happening.” The problem then lies in the assumptions one brings to the question. If science brings the assumption of naturalism of course it will find no evidence for the miraculous. It would be wrong because it would be passing judgment on a subject outside of its bailiwick. This is true first of all, because natural laws are descriptive and therefore cannot forbid phenomena from occurring. Secondly, because the proposition is that God caused the ‘miracle’, while operating outside of the natural law, proof that an occurrence violated natural law would just establish that an event was indeed miraculous. It all comes down to the existence of God. If God ‘is’, by definition: The supernatural is possible. <sup>10</sup>
