HEADING FOR A SHOWDOWN ?

There were ominous signs on the high seas as challenges to the Israeli naval blockade of Gaza continued. While on land, Netanyahu's government was signaling a loosening of controls by allowing in more goods including some construction materials. This softer tone had the effect of seemingly buying the support of the US and some European governments. Defense Secretary Gates recently warned that the Iranians were capable of hitting Europe with "scores or even hundreds of missiles." With that as background consider that more than a dozen American and Israeli warships – including the aircraft carrier USS Harry Truman and 5,000 marines have passed through the Suez Canal toward the Red Sea. When this went to print DEBKA was reporting that the fleet had arrived in the Persian Gulf after practicing for bombing missions against Iranian targets. Right now Iran has abandoned its plan to send Revolutionary Guard naval units to confront the Israelis. However, the blockade is being challenged again by 2 ships sailing from Lebanon, including one with an all-woman crew...just daring the Israelis to use force. According to the Israeli paper Arutz Sheva, the Israelis have told UN Secretary General Ban Ki-moon, that they are prepared to do just that. The female-manned boat is then a public relations ploy, organized as it is by Samar al-Hajj, a Hezbollah supporter.^{1 2 3 4 5 6 7}

ECONOMICS & REVOLUTION – PART VIII

If you've been taking this ride with us you've watched as the curtain has been lifted somewhat on what I would call: Planned Chaos. It is a tactic used by the Elite to drive the world toward such despair and desperation that it will be willing to accept the solution offered; - a New World Order – Global Governance, if you will. The plan is to form the world into a collection of supra-national groupings – a la the EU – and eventually to form these into a World Government with complete political, economic and inevitably religious control. Now way back in Part II of this series we laid out the premises on which it is based.

1. **Revolutions Are Planned**
2. **There Is A Relationship Between Revolutions & Satanism**
3. **The Global Elites Are Moving Us Toward A Form of International Fascism**
4. **Economic Collapse Is Not Inevitable – But It Is Chosen**
5. **It Will Be Religion That Drives The Revolution**

So far we've looked at what seems to be a looming revolution. The evidence is that it is being planned on many levels. Part of the impetus for that revolution is a collapsing economy which will enable the PTB to rework the system to their benefit. Now, we've detailed some of the relationships between the current government in power in Washington and the 'revolutionary class' of Socialists and Marxists and 60's Radicals. Now we'll start to reveal the more sinister side of Revolution: The darker side of 'Transformation' & 'Change' – and the connection these have to the PTB.

BEHIND THE REVOLUTION

“Take heed that no one deceives you.” (Mark 13:5)

As he awaited his chance to serve his soon-to-be President Barack Obama, - the words of Rahm Emmanuel, - the future Chief of Staff, - dripped with anticipation. By September of 2008 the global financial crisis had struck hard at the big banks and at Wall Street, sending the credit markets reeling. In retrospect, it ensured the election of Mr Obama, the first African American President, - and to the powers that be: It created a golden opportunity. In fairness, it must be noted that the reordering of the system had already begun under the watch of the then lame-duck administration of President George W Bush. The first stimulus bill was rammed through Congress on the second try amid warnings of social collapse and the

concomitant imposition of martial law. Now Emmanuel was speaking plainly. “You never want a serious crisis to go to waste. What I mean by that is it's an opportunity to do things that you think you could not do before. This is an opportunity. What used to be long-term problems -- be they in the health care area, energy area, education area, fiscal area, tax area, regulatory reform area -- ... are now immediate and must be dealt with.”⁸

Am I saying then that there was a long-practiced plan, set into action to transform America and the world?

Well...yeah...sort of...and – not quite! First take President Obama himself. Had the mainstream media allowed full disclosure, it should have been obvious from the campaign just what the Senator from Illinois was bringing to the table. He talked of the redistribution of wealth and how a new interpretation of the Constitution should result in a bigger, more active role for government in shaping not only the markets but the entire American experience. Yet it was the fall from grace of the Bush administration, - and all that it stood for, - that enabled the rise of this created messiah-like figure to assume the office of the presidency. Obama talked of a ‘change you can believe in’ and you can believe that change came almost right from the start of his watch. But President’s Obama, and Bush before him may not be the issue here. Writing in his work, *Apollyon Rising 2012*, Tom Horn makes the point that the real world, - including American presidential elections, - is run by the “unseen shapers of the New World Order”. This book has made the case for the involvement of the NWO folks in guiding world affairs. Stanley Monteith summarizes the case very nicely. “An Occult Hierarchy rules the world, and directs the course of human events. The movement is led by powerful men who reject Christianity, embrace the ‘dark side,’ and are dedicated to the formation of a world government and a world religion. Millions of people seeking ‘a new spirituality’ follow them. They control the government, the media, the tax-exempt foundations, many corporations, and both political parties.” Horn quotes exorcist Gabrielle Amorth in making the point that even “US presidents may be unaware of their role as chess pieces on a terrestrial game board...moved by the god of this world”.^{9 10} Thus Messrs Bush & Obama & Emmanuel may have acted in ignorance, - pursuing their own ends, with benign or mixed agendas, - in the process fulfilling the objectives of the “Occult Hierarchy” that really runs the show.

In the course of that fulfillment their pursuit would have led them to take very ‘natural’ actions to address the issues that they faced. Take for instance the financial crisis of 2008. As alarms were sounding from just about all corners, - Denis Blair, America’s National Intelligence Chief told all that would listen that the implosion of the global financial system was a bigger threat to security than even al-Qaeda.¹¹ Economists pointed to the mounting losses from bad loans that threatened to ‘overwhelm the value of the banks assets’, concluding that a significant number of large US banks were insolvent.¹² As for Britain, the Governor of the Bank of England declared that country to be in “deep recession”, as he prepared to ‘print money’ to meet the crisis and avoid immediate and complete collapse.¹³ All of this signaled profound change. Across the globe, nationalization was in the air. And government money would come with strings and controls of both business practices and compensation.¹⁴ You know, practical socialism. Belgium, Ireland, Great Britain, Greece, Spain and even America, - the World Champion of Capitalism, - were all heading down that road.

Now the reaction to the burgeoning crisis proceeded on several fronts. Unemployment was rocketing upward and banks and other business institutions were falling – or being taken over by governments. The first response of the Federal Reserve and the Treasury Department was to begin printing money like it was going out of style. Economists began to see that we were feeding an inflationary bubble that seems about to explode. According to the Federal Reserve, the money supply increased 271% in just a 5-month period from when the crisis began in September of 2008 until March of 2009¹⁵ And the expansion of the money supply continued, threatening, - that whenever the dam broke, - it would do so with massive economic violence. Threatened by the deepening crisis, China and Russia began calling for the end of the dollar as the world’s reserve currency. Many of the financial elite had seen it all coming. Back in 2008, the central banks of Brazil, Russia, India, China, Venezuela, and Ecuador began buying gold for their reserves, - building a hedge against a failing dollar, - and hurrying that currency’s ultimate demise.^{16 17 18} Not coincidentally the momentum for regional currencies gathered – in the Gulf region, - Africa, and Asia. China, - who had long supported its own economy, - as well as the American lifestyle by buying up American government debt, - T-Bills, - began to look elsewhere. When Treasury Secretary Geithner told a Chinese audience that their American investments were a safe bet, - his remarks drew only derisive laughter.¹⁹ The world was looking for an alternative to dominance by the American superpower. In the face of such news, the World Bank predicted that a flood of unrest could sweep across the globe beginning with the poorest countries.²⁰

Governments found that threat very credible. Driven by fear and a need to control they rejected the legitimate concerns of their citizens and reacted in crazy ways. It got wilder by the day! A secret report generated for the Missouri State Police and titled "The Modern Militia Movement" identified supporters of Presidential candidates Ron Paul and Chuck Baldwin as 'militia influenced terrorists'. It instructed "the Missouri police to be on the lookout for supporters displaying bumper stickers and other paraphernalia associated with the Constitutional, Campaign for Liberty, and Libertarian parties". The report ignored a radical Muslim threat while concentrating on the "militia movement".²¹ [Since when is it illegal to be in favor of the Constitution and liberty?] The Department of Homeland Security ratcheted up their own paranoia with a "Home Environment Threat Analysis" that took aim at "Rightwing Extremism" and "violent radicalization in the United States". This targeted on a national level many of the same groups, adding in folks opposed to gun control, government takeover of the economy, - those who believed we may be living in the Last Days before the return of Jesus the Christ, - and American combat veterans returned from the wars in Iraq and Afghanistan. It also mentioned "conspiracy theorists" who feared the declaration of martial law or "suspension of the US Constitution".²² That general fear on the part of the government of the people, - the body politic, - could explain why the Pentagon stationed a brigade of combat veterans within the continental US, to deal with anticipated domestic disturbances.

Going into the summer of 2008, the military commands of the US, Canada and Britain were all gearing up for what they anticipated would be a severe period of civil unrest. The CIA and Britain's MI5 were monitoring their countries economic situations for signs that violence could break out. In the UK, the armed forces actually went on standby.²³ In the US this recalled a 1984 government plan called Operation Garden Plot, a document designed to deal with "civil disturbance control operations" within the US. It set up the design for the American military to operate against American civilians in all sorts of circumstances of civil unrest. "Disruptive Elements" are defined in the order as "tax protesters, militia groups, religious cults, and general anti-government dissenters". A Department of Defense training manual even marked political protests as "low-level terrorism". That's a pretty broad brush. But here's the most disturbing part. One section "provides for America's military and the National Guard State Partnership Program to join with United Nations personnel in said operations".²⁴

That government paranoia has been brewing for a mighty long time. A 'Tea Party Movement', that brought as many as a million Americans together to protest the growth of government and its intrusion into the lives of citizens was met by Federal surveillance that resembled some fascistic police state of the 1930's.²⁵ In March of 2009 FBI "surveillance was being unleashed" on the organizers of the events. Special agents from 56 FBI offices were ordered to gather information and report back to Washington. Next came "video surveillance and data collection" of those attending.²⁶ Reports streamed in of FBI agents taking film and writing down license plate information at all the rallies.²⁷ All of this was being conducted against the background of further plans by the administration to move the US farther down a road never before traveled. FEMA began Martial Law Drills that focused not so much on Islamic terrorists as "right wing extremists". In the process it extended Federal control, coordinating "international, federal, regional, state, tribal" and local participants. Now a list of those targeted "extremists" is already in the hands of the government. As early as the 1960's the FBI had a list of 'subversives' to be picked up in case of a national emergency. In 2007, the Terrorist Screening Center of the Justice Department was maintaining a list of 700,000 names. By Spring of 2010, National Guard units were openly training to deal with rioting crowds and practicing mass detention techniques.^{28 29 30 31} [*It is good, comrade, that we live in Amerika!*]

In the face of these threats to security new proposals for increased government control over every facet of our existence proliferated. The Obama administration sought not only the reinstatement of the assault weapons ban but a massive registration campaign.³² Individual rights were put in jeopardy. Bills to regulate farming in favor of big agriculture that threatened the very existence of the family farm, were being considered in Congress.³³ The national tracking of food products was on the table. All of these bills to remake American agriculture benefited the very same companies that are so often behind the NWO agenda such as Monsanto and Archer Daniel's Midland and Tyson. On the national sphere, the government was growing in ways reminiscent of the socialism and fascism of the 1920's & 30's. New and expanded government programs and control were the agenda for the Obama administration. The passage of a health care bill transferred control of one-sixth of the US economy to the Feds. Estimates tell us that the new law will over time, force a majority of Americans into the government run plan. The administration moved to increase the power of the Federal Reserve and the government, seeking the right even to seize companies that it felt were essential to the well being of the American economy. Now President Obama is seeking \$50 billion to bail out the states who are themselves facing insoluble budget crisis, threatening tens of thousands of layoff and cutbacks in services.³⁴ And don't forget the administration had

assumed control of both GM and Chrysler, - two of the nations Big-Three automakers. The remaking of the corporate landscape had rendered it scarcely recognizable. And with each new infusion of government money came an imposition of further government control.

Perhaps the scariest aspect of this increasing government control over every facet of life is the proliferation of executive orders that are to be put into effect in the case of a presidentially determined emergency. In other words, at the discretion of the president, these executive orders – promulgated over the course of decades – allow the Federal government to assume control of large swaths of American life. Kennedy’s EO 10995 allows Washington to take over all communications media and suspend First Amendment rights. Over the years other Executive Orders assert executive control over citizens, business, churches, production and distribution, wages, financial institutions, local law enforcement, travel and transportation. President Clinton put the whole Federal emergency apparatus under the control of FEMA. And Obama has set up a National Economic Council and a Domestic Policy Council as well as begun preparing to divide the country into ten administrative districts. This giant apparatus only awaits a ‘national emergency’ to activate it.³⁵

The bill for all of this largesse and the expanding role of federalism rose into the trillions. Money is effectively being printed to cover the gap – and there is no end in sight. Thus China began moving to get out of the dollar, and Russia joined that party. As Chinese financing dries up, the ability for America to continue to afford to project its military power around the world will become increasingly problematic. And if America cannot borrow the money needed to continue to live beyond its means – it may create the conditions necessary for the collapse of the dollar. Some commentators have described this as a global “paradigm shift”, an alteration of the world order that will bring with it new relationships and alliances.³⁶

This new major trend – fed by the global financial crisis - could be characterized as creeping internationalism. The drive toward a new global economic order picked up considerable steam since the crisis began in earnest in September 2008. Possibly the most visible outworking of this new globalism can be found in the revival of the International Monetary Fund. The IMF came out of the G20 meetings held in the Spring of 2009, with a new critical role in the management of the world economy.³⁷ Now the IMF is being put in position to effectively print its own money, and “inject liquidity into global markets”. Since that time the administration has been maneuvering for an expansion of such global controls. What is happening is that the architecture is being put in place for a fully-controlled global economy.³⁸ Thus we are witnesses to the creation of an Elite-dominated form of international fascism. Don’t expect to see the American you grew up with. Welcome to the brave new world.
